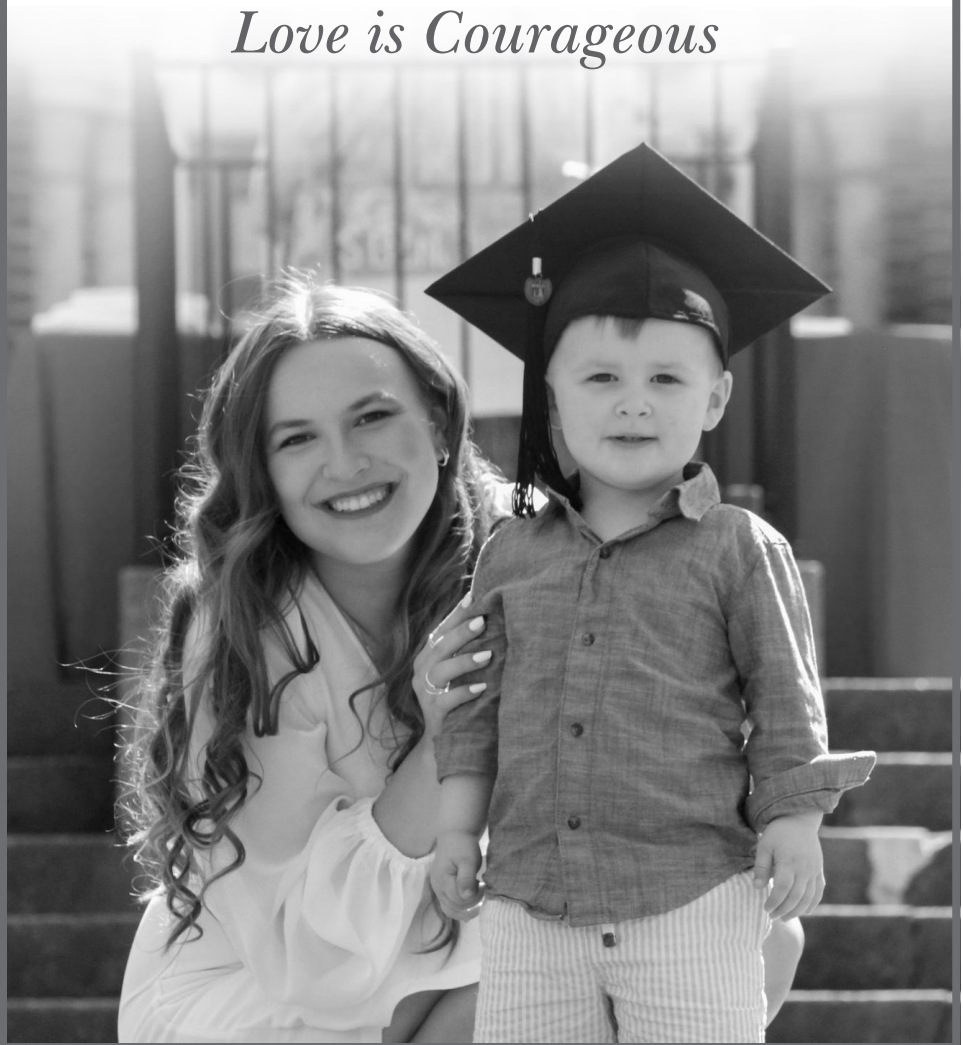

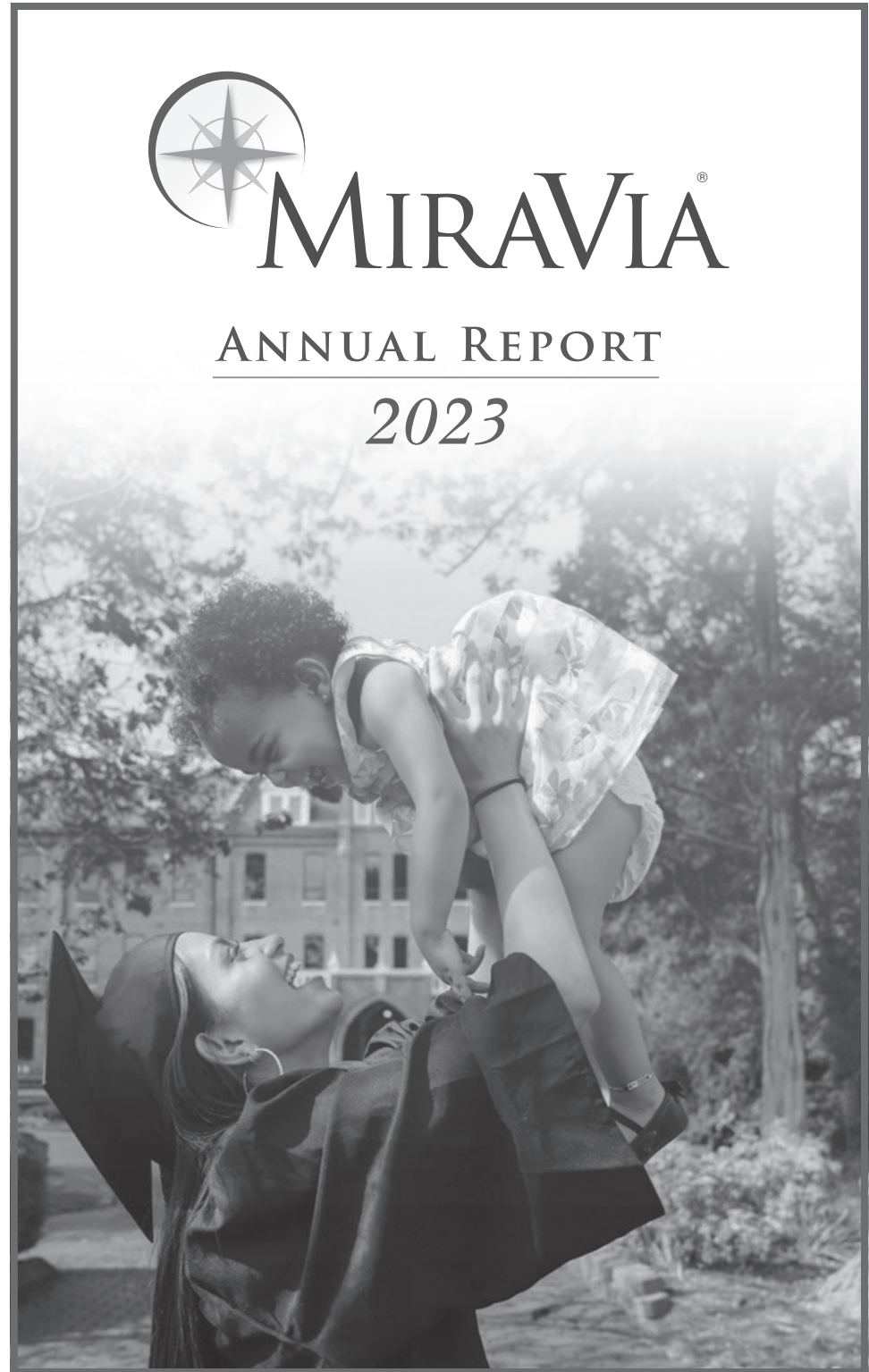

“Take courage! It is I. Do not be afraid.”

When Olivia learned she was pregnant in college, she had no idea how she was going to raise her baby and stay in school. What options did she have? How was she going to tell her parents, keep her friendships, and continue on her path to graduation?

Most often, we see that young women like Olivia feel unsupported, pressured, and alone as they face these difficult questions. *It's hard to have courage when you're so afraid.*

At MiraVia, we are blessed to meet young women like Olivia at this critical time in their pregnancy, and show them that graduating from college as a new mom is possible. With your support, these courageous young women come to live at MiraVia's College Residence, and continue their campus life while enjoying their beautiful gift of motherhood.

It is a joy to see our student moms become good friends, helping each other through daily challenges as they balance going to class, studying, and being a mom. I love watching them as they support one another, cheering for each other's babies as they take their first steps or say their first words. More than just a home on campus, MiraVia provides young women with the opportunity to learn from each other and to share their unique college experience, and to form life-long friendships. We've seen our MiraVia moms grow to be successful young professionals, raising their children while working as nurses, teachers, and paralegals, to name a few. I pray that they carry the love and support that they received at MiraVia with them every day, as they look at their child's first school picture, play games in their backyard, and kiss them goodnight. I pray they look back on these years at MiraVia, their first home, with wonderful memories. Thank you for being part of their lives.

We also love to see our moms at the Outreach Center as they attend their monthly life-skills classes and receive much-needed assistance. These women work hard to provide for their young families, and we are honored to help them along the way. Last year, we transitioned the Outreach Center to a new facility with the goal of serving 25% more women through this program. We have surpassed our goal and have served 35% more women this year. We are so grateful for your support that has helped make this possible.

Together with you, our dedicated and loving donors, we show women that they do not face an unplanned pregnancy alone. We are called to love these women and children courageously every day through our life-saving services. Thank you for your commitment to MiraVia and to our moms and babies.

* *Our Mission*

Respecting and affirming life from the moment of conception, MiraVia is a safe haven and source of hope for pregnant mothers and their children. Invoking a Christ-centered approach inspired by the examples of Mary and Joseph, MiraVia helps young families move toward a new life of hopeful, independent, and healthy living and educates the broader community on the importance of fostering a culture of life.

* *Our Credentials*

MiraVia, Inc. is a 501(c)(3) nonprofit corporation operating in Charlotte, North Carolina. It was incorporated as Room At The Inn, Inc. by the Secretary of State in March 1994 and licensed by the North Carolina Department of Health and Human Services. The organization was rebranded as MiraVia in 2013. Since the first pregnant mother's admission in December of 1994, the residential program has served 599 mothers and children. The nonresidential outreach programs, established in July 2004, have served 11,716 mothers and children. MiraVia is a ministry of the Catholic Church and is listed in the P.J. Kennedy and Sons Official Catholic Directory. Pregnant women are served regardless of their economic, social, religious, racial or ethnic background.

* *Our Services*

MiraVia offers young mothers a way forward through compassionate, long-term support at our College Residence and Outreach Center. Both of these programs invest in the healthy futures of the mother as well as her child, and provide comprehensive services to young mothers to help empower them to choose life for their baby. No other regional program provides such extensive care. These services have been made possible by the generosity of friends like you, our loyal supporters. On behalf of those we serve, thank you.

College Residence serves moms on campus.

MiraVia's College Residence is a place where student moms can live and learn with each other. Located on the campus of Belmont Abbey College, pregnant women from any college or university are welcome to live at MiraVia, free of charge, while we provide everything needed to stay in school and care for their child. MiraVia's services include: on-campus housing, meals, childcare, material assistance, life-skills classes, and around-the-clock support. To date, women have come to MiraVia from 9 states and 12 colleges. MiraVia's College Residence was the first of its kind in the United States, and still among very few to offer such comprehensive, long-term support to young mothers and their children.

Outreach Center serves moms in the community.

MiraVia's Outreach Center provides long-term material support and life-skills classes to pregnant women in need. Centrally located in Charlotte, the Outreach Center provides each mother with diapers, clothing, and baby essentials such as cribs, car seats, and strollers for a full year while they attend monthly peer support sessions on parenting, maternal health, child safety, and life-skills including finance and career counseling. Each mother builds a support community in her peer support group to rely on as she moves beyond this program.
