

* About MiraVia

College Residence serves moms on campus.

MiraVia's College Residence was the first of its kind in the United States, and is still among very few to offer such comprehensive, long-term support to young mothers and their children. Located on the campus of Belmont Abbey College, pregnant women from any college or university are welcome to live at MiraVia, free of charge, while we provide everything needed to stay in school and care for their child. MiraVia's services include: on-campus housing, meals, childcare, material assistance, lifeskills classes, and around-the-clock support. To date, women have come to MiraVia from 10 states and 13 colleges. Last year, 25 student moms and children lived at the College Residence.

Outreach Center serves moms in the community.

MiraVia's Outreach Center provides long-term material support and life-skills classes to pregnant women in need. Centrally located in Charlotte, the Outreach Center provides each mother with diapers, clothing, and baby essentials such as cribs, car seats and strollers for a full year while they attend monthly peer support sessions on parenting, maternal health, child safety, and life-skills including finance and career counseling. Each mother builds a support community in her peer support group to rely on as she moves beyond this program. Last year, 1,360 mothers and children were served through the Outreach Center.

Dear Friends of MiraVia,

Love does not rejoice in wrongdoing, but rejoices in the truth. It bears all things, believes all things, hopes all things, endures all things. - 1 Corinthians 13:6-7

As MiraVia celebrates our 30th year of service, we reflect on the thousands of lives that we have touched, creating lasting change for generations of families.

The young women who find their way to MiraVia are searching for answers to the many questions and obstacles they face during an unplanned pregnancy: How am I going to raise a baby on my own? How will I finish my college education? How can I afford to care for my child?

It is often because of these fears and challenges that many pregnant women who come to MiraVia feel isolated, unsupported, and with no safe place to turn. It is our goal to welcome these young women with open arms, regardless of where they come from, and help them to find their source of hope and joy as they prepare to welcome their baby.

At our College Residence, pregnant college women are welcome to stay at MiraVia while we provide everything needed for student moms to finish their college education and raise their baby in a safe, loving home on campus. During this time, our moms are experiencing the joys of motherhood alongside other student moms, while setting goals in order to graduate and begin their careers. In the past year, we have welcomed 25 student moms and children to MiraVia. Thank you for being part of their lives.

We're also committed to making our services visible to pregnant college women from across the country. MiraVia remains one of very few organizations to provide long-term support to student moms, and we work to ensure that pregnant college women at any college or university are aware of our services. To date, we have served young women from 10 states and 13 colleges.

More than the support that MiraVia offers to young women, we provide a home where our moms and their precious babies feel accepted, loved, and cared for. It is a joy to see our student moms become great friends, cheering for one another through their daily challenges. Our staff rejoices with our moms as we watch their babies take their first steps and say their first words.

At our Outreach Center, moms in our community come to receive much-needed material assistance, opportunities for education, and loving support. These mothers work hard to provide for their families, and we are here to support them along the way. Our moms receive a monthly supply of material goods including diapers, clothing, and baby items such as car seats and strollers, while they also attend life-skills classes offered in both English and Spanish. We also work with our moms to identify their families' needs and connect them to resources in our community. In the last year, our Outreach Center has served 1,360 mothers and children, the most ever served by this program. Thank you for helping MiraVia to expand our Outreach services.

Together with you, our dedicated and loving donors, we rejoice in the truth that these precious babies are worthy of life, that they are wanted and loved. We are proud to show young mothers the compassion they need so they can go out in the world and achieve their dreams for their young families.

Respecting and affirming life from the moment of conception, MiraVia is a safe haven and source of hope for pregnant mothers and their children. Invoking a Christ-centered approach inspired by the examples of Mary and Joseph, MiraVia helps young families move toward a new life of hopeful, independent, and healthy living and educates the broader community on the importance of fostering a culture of life.

Our Credentials

MiraVia, Inc. is a 501(c)(3) nonprofit corporation operating in Charlotte, North Carolina. It was incorporated as Room At The Inn, Inc. by the Secretary of State in March 1994 and licensed by the North Carolina Department of Health and Human Services. The organization was rebranded as MiraVia in 2013. Since the first pregnant mother's admission in December of 1994, the residential program has served 624 mothers and children. The nonresidential outreach programs, established in July 2004, have served 13,076 mothers and children. MiraVia is a ministry of the Catholic Church and is listed in the P.J. Kenedy and Sons Official Catholic Directory. Pregnant women are served regardless of their economic, social, religious, racial or ethnic background.

Our Services

MiraVia offers young mothers a way forward through compassionate, long-term support at our College Residence and Outreach Center. Both of these programs invest in the healthy futures of the mother as well as her child, and provide comprehensive services to young mothers to help empower them to choose life for their baby. No other regional program provides such extensive care. These services have been made possible by the generosity of friends like you, our loyal supporters. On behalf of those we serve, thank you.




